
October 2019 Accomplishment Report



I. SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of October 2019, NFA procured 152,003 MT of palay, which is 96% accomplishment of the month's target of 157,655 MT. The high procurement is attributed to the onset of harvest season and high buying price of NFA at P19.00/kg. The January to October 31, 2019 procurement is 68% accomplishment or 494,554 MT of palay procured of the annual operational target of 723,000 MT, and 127% accomplishment of the original Council-approved procurement target for the year.



DISTRIBUTION

For the month of October, NFA distributed 35,830 MT of rice, equivalent to 25.72% accomplishment of the month's target of 139,304 MT. The low distribution can be attributed to abundant supply of imported rice in market. January todate accomplishment is 62% equivalent to 639,708 MT of the annual target of 1,025,710 MT.



PRICES

Based on the Philippine Statistics Authority (PSA) summary ex-farm prices of palay/rice, the average ex-farm price posted a decrease of P1.51 from last month's price of P16.05 to P15.49 for this month. This is P 3.51/kg. lower than the buying price of NFA at P19.00.

Wholesale and retail prices of WMR and RMR posted decreases of \$\text{P}0.54/kg\$ and \$\text{P}0.29/kg\$. and \$\text{P}0.47/kg\$ and \$\text{P}0.51./kg\$. respectively. Prices of white corn decreased by \$\text{P}0.16/kg\$. on the wholesale level and an increased by \$\text{P}1.20/kg\$. on the retail level. On the other hand wholesale and retail prices of yellow corn both increased by \$\text{P}0.40/kg\$. and \$\text{P}0.15/kg\$.

II. BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

As of October 31, 2019 NFA stock inventory of 9,081,527 bags (total rice equivalent – TRE) or 454,076 MT, is good to last for 13.93 days, based on the 2019 national daily rice consumption requirement of 32,593 MT.

NATIONAL QUALITY ASSESSMENT REPORT (QSAR) ON NFA STOCKS

The total volume of assessed NFA stored grains as of October 31, 2019 was 12,487,700 bags, composed of palay, milled rice and corn grains, an increase of 22.99% from September volume of 10,153,537 bags. Stocks fit as food (rice) and feed (corn) represent 99.995% of the total assessed grains. Stocks for disposition were 445.20 bags, composed of (0.005) totally damaged milled rice.

FOOD DEVELOPMENT CENTER

Testing

For the month of October, FDC performed 2 physical and sensory evaluation, 88 chemical analysis and 89 microbiological quality evaluations, to determine safety and quality of white rice, brown rice, corn grits, other cereals, and various food and food products. Other activities included the testing of packaging materials and label evaluation, heat penetration, and heat distribution test to establish and/or evaluate adequacy of thermal processes of canned goods; shelf life testing to establish shelf life of various packaged products; and the conduct of seminar/training.

Cooperative Development Incentive Fee (CDIF)

For the month of October 2019, the CDIF balance of 1,734 farmer organizations nationwide amounted to £51,808,050.76. CDIF utilization for the month of October amounted to £5.747M, used for the purchase of farm inputs/fertilizers, and comprised 30.19% of the total utilization of the fund. The other 57.59% was used to purchase NFA rice.
