
November 2022 Accomplishment Report

PALAY PROCUREMENT


For the month of November, NFA procured 873,200 bags or 43,660 MT of palay, which is 28.75% accomplishment of the month's target of 3,036,800 bags or 151,840 MT. The low procurement accomplishment and the slight decrease in volume of procurement compared to last month's level is due to the end of harvest season. Despite end of harvest, National Food Authority will still continue to provide the best service to farmers and farmers organization, to entice them to sell their harvested stocks to NFA.

DISTRIBUTION

For the month of November, NFA distributed 353,366 bags or 17,668.3 MT of rice, equivalent to 109.54% accomplishment of the month's target of 322,580 bags or 16,129 MT. A total of 115,765 bags of rice were issued to DSWD and LGUs for relief operations and calamity response.

NFA INVENTORY

As of November 30, 2022, NFA's stock inventory of 2,463,871 bags (total rice equivalent –TRE) or 123,193.55 MT is good to last for 3.67 days, based on the daily rice consumption rate (DCR) of 671,720 bags or 33,586 MT. However, based on Average Daily Sales of 51,463 bags, the inventory is good to last for 47.88 days. It should be noted that NFA's inventory is only part of the national rice inventory of the entire country.
