
October 2022 Accomplishment Report

PALAY PROCUREMENT


For the month of October, NFA procured 1,042,685 bags or 52,134.25 MT of palay, which is 23.81% accomplishment of the month's target of 4,379,800 bags or 218,990 MT. Increase in volume of procurement compared to last month's level can be attributed to continuous effort of the National Food Authority to provide the best service to farmers and farmers organization, for them to sell their harvest to NFA.

DISTRIBUTION

For the month, NFA distributed 412,263 bags or 20,613.15MT of rice, equivalent to 43.85% accomplishment of the month's target of 940,130 bags or 47,006.5 MT. Slight increase in volume of distribution compared to last month's level can be attributed to the rice releases activities to DSWD and LGUs intended for Calamities and COVID-19 relief operations.



I. BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

NFA INVENTORY

As of October 31, 2022, NFA's stock inventory of 2,393,878 bags (total rice equivalent –TRE) or 119,639.9 MT is good to last for 3.56 days, based on the daily rice consumption rate (DCR) of 671,720 bags or 33,586 MT. However, based on Average Daily Sales of 24,288 bags, the inventory is good to last for 98.56 days, it should be noted that NFA's inventory is only part of the national rice inventory of the entire country.
