

#### PALAY PROCUREMENT


For the month of September, NFA procured 142,388 bags (7,119.4 MT) of palay, which is 6.65% accomplishment of the month's target of 2,140,570 bags (107,028.5 MT). Increase in procurement this month can be attributed to the additional Buffer Stock Incentive approved by the NFA Council and with the continuous effort of the agency to provide the best service to farmers and farmers' organization, to sell their harvest to NFA.

### DISTRIBUTION

For the month of September, NFA distributed 86,365 bags (4,318.25 MT) of rice, equivalent to 13.19% accomplishment of the month's target of 654,810 bags (32,740.5 MT). A total of 32,626 bags of rice were issued to LGUs and DSWD for relief operations and response to calamity.

#### NFA INVENTORY

As of September 30, 2023, NFA's Total Expected Milled Rice Inventory (TEMRI) stock inventory of 884,793 (44,240 MT). It should be noted that NFA's inventory is only intended for relief operations and calamity response and only part of the national rice inventory of the entire country.
