
April 2023 Accomplishment Report

PALAY PROCUREMENT


For the month of April, NFA procured 137,358 bags or 6,867.9 MT of palay, which is 6.33% accomplishment of the month's target of 2,170,360 bags or 108,518 MT. Increase in procurement compared to last month's level (63,964 bags) can be attributed to the good harvest of the summer cropping season and the continuous effort of the National Food Authority to provide the best service to farmers and farmers organization, for them to sell their harvest to NFA.

DISTRIBUTION

For the month of April, NFA distributed 70,678 bags or 3,533.9 MT of rice, equivalent to 16.15% accomplishment of the month's target of 437,710 bags or 21,885.5 MT. A total of 21,157 bags of rice were issued to LGUs and DSWD for relief operations and response to calamity.

NFA INVENTORY

As of April 30, 2023, NFA's stock inventory of 1,097,053 bags (Milled Rice) or 54,852.65 MT is good to last for 3 days, based on the daily rice consumption rate (DCR) of 679,670 bags or 33,983.5 MT. However, based on Average Daily Sales of 5,186 bags, the inventory is good to last for 386 days. It should be noted that NFA's inventory is only part of the national rice inventory of the entire country.
