THIS AGREEMENT made the 29th day of NOVEMBER 2023 between **National Food Authority Region VI Western Visayas**, Quintin Salas, Jaro, Iloilo City of the Philippines (hereinafter called "the Entity") of the one part and **Avega Bros. Integrated Shipping Corp.** of 8070 Tanguile St., Cor. Estrella Avenue, Makati City (hereinafter called "the Supplier") of the other part;

Integrated Shipping Corp.**, agrees to provide **Vessel Services for the Transfer of 30,000 bags of Local Rice from NFA Region VI to NFA Region VIII Through Negotiated Procurement under Emergency Cases** in accordance with his/her/its Bid.
 4. The **National Food Authority Region VI Western Visayas** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
