3. The highest bidder shall be determined from the offer tendered per lot and one bidder **should bid on all lots**. Do not leave any **blank entries on the tender form** or the form will be declared null and void
4. A **Bidder's Bond equivalent to Ten Percent (10%)** of the total amount of the offer in the form of CASH, MANAGER'S OR CASHIER CHECK in favor of NFA shall accompany the sealed offer, otherwise, the offer shall be automatically rejected;
5. A non-refundable **bidding fee of Five Thousand Pesos (P5,000.00)** shall be paid before issuance of Tender Form. The Bidding documents must be free from erasures/alterations, otherwise it will be declared null and void. Bidding documents can be purchased at the amount of P100.00 as replacement to the spoiled Bid Document;
6. Payment of the lot as bid shall be made within Forty Eight (48) hours from receipt of the Notice of Award either in CASH, MANAGER'S OR CASHIER CHECK. In the event that the awardees fail to remit the amount within the period, the Bidder's Bond shall be deemed automatically forfeited in favor of NFA without necessity of court action. If the payment is made within the period, the Awardee's Bidder's Bond shall be released but shall be considered performance Bond for the faithful performance of Awardee's obligation in the withdrawal of the unserviceable properties and fulfillment of the other conditions of the award;
7. All incidental expenses in the withdrawal of the unserviceable properties like handling and hauling expenses shall be borne by the awardee;
8. Withdrawal of the awarded unserviceable properties must be made and completed within the following period from the date of payment:
  - a. Lots 1, 2 and 3      fifteen (15) working days
  - b. Lots 4 and 5        fifteen (15) working days
  - c. Lots 6, 7, 8 and 9    fifteen (15) working days

10. Prospective Bidders are required to submit **valid original and one photocopy** of the following documents:

- a. Letter of Intent to participate in the public bidding duly signed by the bidder or his duly authorized representative.
- b. Latest Mayor's Permit / Business License
- c. Certificate of Registration with DTI / SEC
- d. Valid ID
- e. For authorized representative, duly notarized Special Power of Attorney (SPA) from the principal bidder.

11. All minimum health / safety protocols relative to the mitigation of COVID19 will be strictly observed.

The Branch Fixed Assets Inventory, Evaluation and Disposition Committee reserves the right to reject any or all bids without offering any reason, waive any formality /defect contained therein and to award to the bidder whose bid as evaluated by the FAIEDC the most advantageous to the government.
