

NFA R-3 WELCOMES BIOCO, UY: TWO IN THE LEAD



RODERICO R. BIOCO NFA Administrator

As the new NFA Administrator, Roderico R. Bioco took oath of office before Executive Secretary Lucas P. Bersamin on January 18, 2023 and subsequently was appointed as vice-chairperson of the NFA Council on March 27, 2023.

Bioco, a BS Mathematics graduate of Ateneo de Manila University, established himself in the grains sector by assisting Mindanao's corn farmers. With decades of experience in the grains industry, he is renowned for assisting the nation's small farmers by promoting beneficial legislation and setting up a business with a genuine social commitment to the farmers. With this, he is challenged to do the same in the nation's rice agency.

He is an acknowledged leader in the field of agriculture with decades of experience as a farmer of corn, cassava, and livestock. He is also an industrialist who built important post-harvest facilities for corn in the nation and an advocate for agricultural policies who upholds the welfare of our smallholder corn farmers.

Prior to his appointment by President Marcos, Bioco was the CEO of Mindanao Grains, a corn processing company based in Bukidnon. He was also the founding chairman of the Philippine Maize Federation, Inc. (PhilMaize), a national organization of corn farmers and cooperatives. His extraordinary efforts and achievements have boosted the corn business and empowered the welfare of our corn farmers.

Bioco administration intends to pursue major NFA transformation outlined in five (5) main components: 1) Masagana Food Infrastructure Modernization for Food Security and Nutrition to meet global standard for food safety, manufacturing and work place safety: HAC-CP, GMP and OSHA; 2) Sustainable Agri-Industrialization Program (Circular Economy); 3) Strategic Distribution System in partnership with DSWD to meet Calamity Relief, 4Ps, AICS and School Feeding fortified rice requirements; 4) SARAI Digital Transformation, and; 5) HR Restructuring Program

On the other hand, Director Alwin M. Uy officially assumed the duties and responsibilities as the Acting Regional Manager II of NFA Central Luzon effective January 30, 2023 pursuant to Special Order AO-2023-01-007 dated January 26, 2023. He was previously assigned at the Office of the Assistant Administrator for Finance and Administration at NFA Central Office.

During his first meetings with the employees NFA Central Luzon, Dir. Uy emphasized that growth,

progress and success are crucial elements in achieving a successful and winning goal: growth through the acquisition of new skills and knowledge, progress through their application to enhance performance and success through teamwork and the accomplishment of objectives.

As a response, the NFA Central Luzon employees expressed full support to the goals, planned reforms and directions of the new administration to bring better changes within the organization. Known as a man of action, Dir. Uy prioritized the re-evaluation and deliberation of NFA Central Luzon employees in acting capacity to find the best fit to all vacant positions to strengthen the agency's ability to deliver excellent government service. As the region embraced changes, Director Uy guided and encouraged NFA Region III employees as they engaged to major activities such as massive palay procurement, rice distribution to relief agencies, implementation of Palay Marketing Assistance Program for Legislators and Local Government Units PALLGU), release of One-Time grant of Rice Allowance (OTRA) to Administrative pursuant Order No. 2, series of 2022 by President Ferdinand R. Marcos, Jr., participation to Kadiwa ng Pangulo Program, and continuous ties/ linkages to LGUs and stakeholders through conduct and attendance to ugnayan/meetings and assemblies.

We can't be sure of what the future holds, but he hoped that the so far accomplishment during his first 100 days has clearly proved the level of dedication, passion, and commitment his leadership has to deliver the kind of service that the people expect and deserve.

The following are the highlights of NFA Region 3's first 100 days under our new leaders:

The NFA Central Luzon continuously procured palay from our local farmers/farmers' organizations at P19.00/kg that assured them of a fair return on production investment. It included procurement even in far-flung areas of the region thru mobile or pick-up and in-warehouse delivery scheme from individual and organized farmers.

The palay procurement program is the only means for the NFA to acquire and maintain the required buffer stock in line with the agency's function of assuring the availability of NFA rice during emergencies and calamities.

As of May 9, 2023 the region has accumulated a total of 9,320 bags of palay for the summer crop season contributed by the following branches and provinces:

Given all the efforts by the branch offices, the target was not attained primarily because of higher ex-farm prices offered by private traders during the period as compared with that of the NFA. These ranged from P17.50-19.00/kg for freshly harvested palay which was equivalent to P20.25-P22.00/kg converted price for dry palay. Most farmers grabbed the higher prices of private traders considering the increased prices of agricultural farm inputs.

Still, this performance enabled the agency to our local famers with the injection to the local economy of Cereal Procurement Fund (CPF) amounting to P8,854,000.00.

Nevertheless, the NFA Region III is mapping out plans and strategies to improve performance on palay procurement for the next cropping season within the region known to be as the "Rice Granary of the Philippines".



January - May 2023

Palay Marketing Assistance Program for Legislators and Local Government Units (PALLGU) is a program of NFA since 2006 that enables the farmers to earn additional income from the palay produce they sell to NFA. The participating LGUs/Legislators shall enter into a marketing arrangement with NFA where the former provide a certain amount of premium on top of the existing NFA buying price currently set at P19 per kilogram, for the purchase of clean and dry palay from the legitimate farmers.

Among the Legislators/LGUs who entered to a marketing agreement for NFA's PALLGU Program were:

Director Uy stressed the importance of the partnership between the NFA and the Legislators/LGUs through the PALLGU to encourage farmer-constituents' support to the palay procurement program which plays a significant part in achieving the agency's mandate of buffer stocking.



BM PAOLO CRUZ MEETS WITH GOVERNOR YAP FOR PALLGU PARTNERSHIP

Fostering a good relationship with the Provincial Government, NFA Tarlac Branch Manager, Paolo R. Cruz, together with Supervising Grains Officer, Manuel D. Rodriguez, paid a courtesy visit to Tarlac Provincial Governor, Hon. Susan A. Yap on March 3, 2023 at the Provincial Capitol Building, Macabulos Drive, Tarlac City. During the meeting, BM Cruz expressed his gratitude for the governor's continuous support to the agency, especially during the NFA Tarlac's palay procurement operations in the previous year, wherein through the tie-up of NFA and the Tarlac Provincial Government, a provision of premium amount on top of NFA's buying price through NFA's Palay Marketing Assistance Program for Legislators and Local Government Units (PALLGU) and the Yield Assistance Program (YAP) was made possible.

BM Cruz sought the approval of the Honorable Governor for the extension of the program for the year 2023 in order for the farmer-beneficiaries to continuously avail the additional incentive. Gov. Yap, ardently granted the request of the branch for a premium of P1.00/kg allocating P5M from the LGU budget. She even pledged providing additional logistics that will aid the branch during its palay procurement operations. Further, she assured BM Cruz that the provincial government shall ceaselessly support the agency in fulfilling its mandate and shall seek avenues to improve the livelihood of the province's farmer-constituents.



MALOLOS CITY GOVERNMENT SIGNS PALLGU TO SUPPORT LOCAL FARMERS

A Memorandum of Agreement (MOA) was signed on May 3, 2023, between the City Government of Malolos, represented by Honorable City Mayor Atty. Christian D. Natividad, Honorable Vice Mayor Miguel Tengco Bautista, and the National Food Authority Region 3, led by Regional Manager Alwin M. Uy and Bulacan Branch Manager Jimmy M. Mallari. The activity took place at the City Hall of Malolos in the Province of Bulacan.

In support of this program, Mayor Natividad allocated a total of P1 million pesos or premium of P3.00/kg for the year 2023, specifically dedicated to benefiting farmer beneficiaries in Malolos.

The ceremonial signing event was attended by key figures from NFA and local government officials. Farmer-leaders were also in attendance, highlighting the collaborative efforts between the government and the agricultural sector.

It has been a practice by the NFA to prepare all the manpower and logistics requirement even before the onset of each cropping season. For this summer crop harvest of 2023, the NFA branch offices conducted Ugnayan/meetings to promote the Palay Procurement activities of the agency. In addition, other information dissemination and advocacy campaign strategies were initiated like distribution of flyers addressing the frequently asked questions with regard to the palay procurement program. Tarpaulins were also hanged in the respective warehouses/buying stations, mobile trucks and even in conspicuous/ strategic places within the service areas of each branch office.

During Ugnayan/meetings with farmers, farmers' cooperative and associations, partner-agencies, the following were presented, discussed and clarified: A. Palay classification taking into consideration the NFA specifications and parameters as to moisture content, purity and discoloration and damage;

B. Registry System for the Basic Sectors in Agriculture (RSBSA) identification/masterlist as the simplified requirement required by the agency;

C. Process of procurement from delivery or mobile up to payment of palay to farmers;

D. Warehouse/buying stations and other logistics strategically located to areas accessible to the farmers, and;

E. Existing and proposed partnership with LGUs thru PALLGU, an additional premium provided by the LGU on top of the NFA's buying price of P19.00/kg.







BY THE PRESIDENT OF THE PHILIPPINES

ADMINISTRATIVE ORDER NO. 02

AUTHORIZING THE ONE-TIME GRANT OF RICE ASSISTANCE TO ALL GOVERNMENT EMPLOYEES AND WORKERS FOR FISCAL YEAR 2022

The NFA Region 3 started releasing the One-time Rice Assistance (OTRA) to government employees and workers, upon issuance of the approved Special Allotment Release Order (SARO) from the Department of Budget and Management (DBM), in compliance to Administrative Order No. 2 series of 2022, duly issued and approved by His Excellency, PresidentFerdinandR.Marcos, Jr.

Under Section 1 of this Order, the grant of a one-time assistance uniform at quantity of 25 kilograms of NFA rice for each personnel of the National Government who are still in the government service and/or engaged by the government agencies as of November 30, 2022 was authorized. The rice assistance will benefit 1,892,648 government workers tionwide, including Job Orders (JOs) and Contract of Service (COS) personnel.

In accordance with the President's instructions, this will protect the welfare of government employees and workers by providing support for their

their basic household necessities while simultaneously boosting the production of the rice farmers.

As of May 9, 2023, 342 bags of NFA rice have been withdrawn agency-beneficiaries through the assigned focal person from the issuing warehouses of NFA Nueva Ecija, Tarlac and Bulacan. So far, actual issuance was still less than 1% of the total rice requirement of the estimated 152,000 beneficiaries in Region 3. Despite this, NFA branch offices guaranteed to comply not only to complete rice distribution within the set target date of June 30, 2023, but also to ensure that only good quality NFA rice will be issued.

Government Workers

President Ferdinand R. Marcos Jr. launched the Kadiwa ng Pangulo Program to different areas nationwide including the provinces in Region 3 in support to our local farmers. The NFA Region 3 branch offices, through the initiative of Regional Manager II Alwin M. Uy, joined and supported the program wherein selected NFA employees repacked NFA rice into 5-kilogram plastic containers, displayed and sold at P25.00/kg at the following Kadiwa stores:

He assured that the supply would not run out, pledging to open more "Kadiwa ng Pangulo" stores nationwide to support the growth of micro, small, and medium enterprises (MSMEs) and contribute to a healthy economy.

Through the continuous of National support Irrigation Authority - Upper River Integrated Pampanga IrrigationSystems(NIA-UPRIIS) headed by Department Manager Rosalinda B. Bote, the signing of Memorandum of Agreement place on took March 30, Cabanatuan 2023 between Dreamland FIA. Inc. represented by President Victor A. Hernandez and National Food Authority represented by Regional Manager II Alwin M. Uy and Acting Branch Manager Jimmy M. Mallari.

The program aims to support the agency's mandate to have a sufficient rice buffer stock that is sourced solely from local farmers and well distribution

With the continuous meetings and follow-ups with NIA-UPRIIS Cabanatuan Dreamland INC agreed to enter into MOA with the agency pledging to deliver palay of not lower than ten (10) bags each hectare of farmers. On March 31, 2023, the IA initially delivered a total of 200 bags of palay. They were the second IA of NIA-UPRIIS to tie up with the NFA on EPAHP Program.

NIA-UPRIIS PLEDGES SUPPORT TO NFA'S PROCUREMENT PROGRAM

The National Food Authority Region 3 and the Irrigators' Association entered into a Memorandum of Agreement (MOA) on March 13, 2023 at Sta. Rita Warehouse, San Miguel, Bulacan agreeing the latter to deliver palay to NFA during procurement season with minimum of three (3) bags per hectare from each farmer-members.

The ceremonial signing was held between the NFA Region 3 represented by Regional Manager II Alwin M. Uy and Acting Branch Manager Sheryl G. Catolico, and NIA-UPRIIS headed by Department Manager Engr. Rosalinda Bote, and Engineering and Operations Division Manager Engr. Vivencia Dela Cruz. The presidents of the different Irrigators Association and NFA personnel also graced the occasion.

Director Uy highlighted the importance of ensuring a reasonable rate of return for Filipino farmers and providing an adequate supply of rice for the country. He also emphasized the agency's commitment to buy farmers' palay and ensure their income, especially when farmgate prices are low.



The MOA signing marked an important milestone for both NFA and the Irrigators' Association in efforts to support local farmers and ensure a stable food supply for the country. With this partnership, both parties are optimistic that they will be able to achieve their shared responsibilities of empowering the agriculture sector and promoting food security in the country.



NFA REGION 3 CONDUCTS PALAY PROCUREMENT BRIEFING

The NFA Region 3 branch offices conducted Palay Procurement Briefing to the procurement teams which included warehouse personnel, cash disbursing officers, classifiers and job orders in anticipation of the onset of summer cropping season.

The briefing was organized to abreast the procurement personnel on the guidelines and recent instructions to ensure smooth and efficient operations during procurement. Regional Manager II Alwin M. Uy and Acting Assistant Regional Manager Me-ann

C. Villaflor, together with the branch managers, called for an increased efforts in accomplishing the number one goal of the agency, which is maintaining its buffer stocks through palay procurement.

The discussions highlighted the following:

- 1. Warehouse Stock and MTS Documentation
- 2. Grains Procurement Policies and Procedures
- 3. Warehouse Policies and Procedures including Good Warehouse Keeping Practices
- 4. Guidelines in Designation and Fielding of Warehouse Supervisors

- 5. Grains Classification
- 6. Cash Disbursement Procedures
- 7. Implementation of Palay Marketing Assistance Program for Legislators and Local Government Units (PALLGU)

Through the presentations and discussions shared by competent and officials, speakers the gained personnel deeper understanding of the guidelines and procedures associated with their roles. Afterwards, a forum was opened to entertain questions and concerns of all atendees which were addressed by the concerned section heads.

The Power of Perseverance: Mang Amado's Success Story

When equated to life, leaves on trees fall and then resprout. Just with every harvest season at the National Food Authority, farmers come and go. That is how life works....

The tree, as a magnificent creature with well-anchored roots, will flourish and endure for a very long time, just like an 85-year-old farmer, Mr. Amado R. Domingo Sr., from Macatbong, Cabanatuan City, Nueva Ecija, whose loyalty and commitment to the agency is immeasurable.

The journey of "Mang Amado," as the employees at the NFA Nueva Ecija Branch Office affectionately refer to him, is full of astonishment, difficulties, wonderful moments, and experiences that define him as a person, a parent, a friend, and a farmer.

Living on a farm may appear to be quite labor- and energy-intensive. He started farming when he was just 17 years old, using just one (1) hectare of available agricultural land in Macatbong, Nueva Ecija.

He has been a farmer since the dawn of time, cultivating his crops using the direct seeding technique, which involves sowing the seeds right into the ground. Due to the lack of irrigation, timing and quality of land preparation are critical factors for growth and yield of rice. By using a carabao to plow the ground, he prepares it for primary tillage, levels it, and then plants the crop. He also makes sure that bunds are tightly compacted and securely shut. For four months, he will keep an eye on the state of his crop for he believes that proper land preparation facilitates water, nutrient and pest management for him to have a good and bounty harvest.

The Granary Vol. 1 No. 1 January - May 2023 Farming requires patience because the rewards of one's labor are sometimes delayed by drought, making it like a long waiting game. According to Mang Amado, he started selling his yields since the Rice and Corn Administration. Since then, he has consistently sold his palay to the NFA, regardless of the quantity, the price on the market at the time, or the conditions.

When asked if he had ever sold his produce to the traders, he answered, "Oo, kaso lugi sa timbang kapag sa labas nagbenta ng palay."

Mang Amado, like the other farmers, was unable to pursue his schooling due to financial restrictions, nonetheless, was able to raise his six (6) children by laboring in the fields with his own bare hands. He was in terrible pain when one of his children died, but he never loses faith and hope.

Despite the challenges, his passion for his work has propelled him to expand his agricultural area from one (1) to seven (7) hectares.

As a parent, given his advanced age, he has decided to leave his six (6) children a bequest of six (6) hectares of his farmland in the hopes that they will uphold his advocacy for farming and develop enduring values. Back where he started his farming career, he is currently cultivating just one acre of land.

Being an enthusiastic farmer, he is familiar with the programs and projects of the various government organizations that deal with agriculture. When it comes to the benefits that he gained from the government and farming, he vigorously answered, "Sa pagsasaka, nabuhay ko ng maayos at marangal ang aking pamilya, nakapagpundar ng kalabaw at hand tractor. Ang gobyerno, malaki ang naitutulong sa amin, sa DA, nakakakuha kami ng libreng punla at pataba. Ang NFA noon, nabigyan na din kami ng fertilizer na libre, nabigyan din ako ng pagkakataon na makapagbenta ng bigas."

As a friend, he never stops encouraging other farmers to sell their palay produce to the NFA. As to how he helps other farmers, he replied, "Kapag nagrenta ako ng sasakyan ng palay para magdeliver, isinasabay ko na din ang sa ibang kalapit na farmers para hindi na sila gumastos pa sa transportasyon. Sa mga kooperatiba naman, nahikayat ko sila na kumuha ng Master's Passbook sa NFA."

In 2022, his farm and other sources of income were damaged by Super Typhoon Karding, producing only 11 bags of palay. In the dazzling light of a new day, he simply walks from his home to NFA to sell his produce while taking in the vista, kissed by the sun, with nothing in his pocket.


Perhaps, though, it was a heartbreaking scenario to witness an old, tired man still smiling despite the pain he endures while walking. It was wonderful, priceless, and precious event for the NFA-NEBO, onethat each employee will carry with them forever.

Mang Amado is a man who has devoted his entire life to farming with passion, patience, and perseverance.

A man who still has the stamina to stand up with pride and always lend a helping hand, like a bough that stretches up in the sky, under the sun, and has weathered the number of years.

A person whose commitment to the National Food Authority is comparable to the firmly planted roots of a tree and whose respect and trust for the organization are unfathomable.

In conclusion, as he often says, the NFA has greatly aided him to continue his farming because he is aware that the organization always supports and defends farmers constantly.

FROM SCRAP TO CRAFT

A simple mobile grains collector made of locally available and scrap materials was designed, fabricated, and tested for collecting and bagging of different grains on concrete pavement (solar drier).

This innovation by Mr. Richard Joseph H. Magcalas and his wife, Ms. Catherine M. Magcalas, Acting Warehouse Supervisor of NFA Nueva Ecija Branch Office, was undertaken to help the agency on the following reasons:

- 1. Reduction of grains losses
 - 2. Reduction of labor cost
 - 3. Saving of time and energy

Initially, grains are manually loaded into a dustpan by pushing the grain bagging machine. The hand wheel is then rotated so that a gear can push the rack to move upward. Finally, the dustpan tilts to pour the grains into the empty sack. This simple machine has the following major parts: frame, wheel, long and wide funnel and an empty sack.

This innovation has provided us opportunity to use gained knowledge on helping our agency to promote such technology and be available to users with very minimal expenses.


