NFA ATTENDS THE RICE INDUSTRY STAKEHOLDERS ENGAGEMENT (RISE)




The National Food Authority, headed by Administrator Roderico R. Bioco, attended the Rice Industry Stakeholders Engagement (RISE) together with the Department of Agriculture attached agencies at the Philippine Rice Research Institute (PhilRice) and Philippine Center for Postharvest Development and Mechanization (PHilMech), Science City of Munoz, Nueva Ecija on July 27-28, 2023.

The two-day engagement was led by DA Undersecretary Leocadio Sebastian, which focused on the rice industry's current situation, key strategies, provision of support to rice clusters to attain stable rice supply, high farm productivity, high income for rice farmers and, modern and transformed rice industry.

Mr. Jonathan D. Yazon, Acting Department Manager for Operations and Coordination Department (OCD), presented the Contract Growing Scheme between NFA and Rice clusters through the agency's specific strategies and assistance. Likewise, Administrator Bioco also discussed the modernization of food infrastructure to reach the optimal level of government rice buffer stock and further

explained the establishment of partnership Farmer between Cooperatives and Associations (FCAs) and Irrigators Associations (IAs) in the NFA Palay Procurement Program towards the enhancement of rice production and supply through technological adoption and value chain development in the rice industry.

Special Assistant Engr. Roger V. Navarro and the Regional Managers of Regions 1-15 were also in attendance.





ADMINISTRATOR BIOCO VISITS THE NUEVA ECIJA RICEMILL



Administrator Roderico R. Bioco, together Regional with the NFA Executives, Directors and Department Managers conducted a study tour/visit on July 29, 2023 to the Guimba-based Nueva Ecija Ricemill/Rice Processing Center, which is owned and operated by the Provincial Government of Nueva Ecija under the leadership of the Honorable Governor Aurelio M. Umali. OIC Provincial Agriculturist Jovita Agliam, PhD., who eagerly explained its scope of operation in the province, assisted the team. The facility operates a 10TPH Ricemill, five (5) units Recirculating Mechanical Dryer at 30TPB capacity per unit, and a newly installed four (4) Silos with 1500 metric tons capacity per silo.

This visit was substantial as the NFA is realizing its transformation and modernization plan that may assist the agency mission for buffer stocking primarily intended for calamities and emergencies.

Administrator Roderico Bioco undertook a Saturday morning inspection of rice mills in Bulacan, including the Golden City and Intercity, Bocaue, on October 28, 2023. Accompanying him were CPMSD Director Dr. Mario Andrada, Region III Regional Manager Engr. Alwin Uy, Acting Branch Manager Benjamin De Guzman, Acting ABM Rhona Talens, and SGO Jeanette Go.

The visit was centered on an in-depth conversation about the rice price cap, covering everything from its inception to its eventual lifting. It addressed the repercussions of rice importation, highlighting the challenges it posed to domestic rice production and the livelihood of local farmers emphasizing a commitment to finding more streamlined and effective procedure and solutions which balance the interests of various stakeholders.

PALAY PROCUREMENT

The agency's transition from its previous function to its new mandate brought new experiences, challenges and opportunities from growth and transformation. On September 18, 2023, the NFA Council, per Memorandum No. AO-2023-09-014, has approved the provision of Buffer Stocking Incentive (BSI), which shall augment the NFA's palay buying price to encourage more farmers to deliver palay to NFA and assured of a fair return on their investment. With this guidelines, the buying price of palay increased from P19.00/kg to P23.00/kg for clean and dry palay with 14% moisture content (MC) and P16.00/kg to P19.00/kg for wet palay with 22%-29.9% moisture content (MC) thus, gives an opportunity to the NFA to intensify its procurement operations.

For the period July to December 2023, the region has accumulated 56,488 bags of palay for the main crop season contributed by the following branches and provinces:

Despite the additional premium from the PALLGU Partnership with the Provincial Government and LGUs, extra efforts put forth by the regional office, and the diligent work of the procurement teams, the struggle to secure palay persisted; hence, the target for the semester was not attained primarily because of the higher ex-farm prices offered by private traders as compared with that of the NFA. These ranged from P19.00-26.00/kg for freshly harvested palay, which was equivalent to P22.00-P30.00/kg converted price for dry palay. Farmers seized the higher rates offered by private dealers in light of the rising costs of agricultural farm supplies.

Nevertheless, the NFA Region III is mapping out plans to ensure a stable supply and continues to explore creative and innovative solutions and strategies to improve performance on palay procurement for the next cropping season.

UGNAYAN ACTIVITIES

NFA REGION 3 SETS GRAND UGNAYAN WITH STAKEHOLDERS

On September 29, 2023, the NFA Region 3 branch offices hosted the Grand Ugnayan with stakeholders as part of a series of proactive engagements aimed at fortifying relationships with local farmers. The NFA personnel headed by the Branch Managers and Assistant Branch Managers, encouraged farmers to participate in the agency's initiatives, with a special emphasis on palay procurement. The NFA's new buying price as well as other incentives like the recently approved Buffer Stock Incentive (BSI) and the Palay Marketing Assistance Program (PALLGU) were also discussed.

Withtheparticipation of DA-MAO/MAFC, NIA, cooperatives and associations in promoting the intensified procurement program of the agency, local farmers committed to deliver bags of palay for the upcoming main crop procurement season, pledging continued support for NFA's initiatives. With this collaboration, it emphasized the positive impact on the availability, affordability, and accessibility of rice in the country. These extensive initiatives demonstrate the region's commitment to modernizing and bolstering the agriculture industry while promoting harmony and winning the unwavering support of regional partners and stakeholders. The branch offices concluded by thanking the attendees and restating the region's dedication to ongoing stakeholder collaboration.

PALAY AGREEMENT MARKETING ASSISTANCE PROGRAM FOR LEGISLATORS AND LOCAL GOVERNMENT UNITS (PALLGU)

The partnership between the LGUs/legislators and NFA thru the PALLGU program continues to grow with other provinces hence, encouraging more local farmers to sell their palay produce to NFA towards the attainment of agency's mandate of buffer stocking.

This was to seek assistance by giving additional premiums per kilogram of procured palay on top of NFA's buying price to maximize the income of the local farmers.

This program was continuously conducted by the branches in different municipalities despite the continuous challenge of high ex-farm price. The high hopes to encourage the LGUs in the program will surely be a great help both in the agency's mandate to ensure the optimal level of buffer stocks and to enable our local farmers to gain additional income for their produce.

ACCOMPLISHMENT HIGHLIGHTS STRENGTHENING FOOD SECURITY: NFA TARLAC AND LGU MONCADA FORGE VITAL PARTNERSHIP

In a milestone commitment to bolster food security and elevate public service standards, the National Food Authority (NFA) Tarlac Branch Office and the Local Government Unit (LGU) of Moncada, Tarlac officially entered into a Memorandum of Agreement (MOA) on the Palay Marketing Assistance Program for Legislators and Local Government Units (PALLGU).

Inked on June 19, 2023, the LGU Moncada, led by their dedicated Local Chief Executive, Hon. Estelita M. Aquino, pledged a total allocated budget of FOUR MILLION PESOS (P4,000,000.00) which equates to an additional premium of P2.00 per kilogram on top of NFA's buying price for 400 selected farmer-beneficiaries within the municipality.

"Para sa mga magsasaka ng Moncada, para sa Bayan ng Moncada," exclaimed Mayor Aquino, expressing her optimism and joy at the partnership with NFA. She emphasized that the program would not only benefit the local farmers but also contribute to the country's overall food security. This also aimed to provide additional income to local farmers and ensure a sufficient buffer stock for use during emergencies and calamities.

The ceremonial signing took place at the SB Hall, ABC Building in Moncada, Tarlac, and pictured the representation of Engr. Alwin M. Uy, Regional Director of NFA Region 3, and Hon. Estelita M. Aquino, Municipal Mayor of Moncada. Also present during the signing were NFA TBO Branch Manager Engr. Charles Alingod, OIC-MAO Mr. Eduardo Balgos Jr., and members of the Sangguniang Bayan of Moncada. This significant event solidified a vital partnership between the NFA Tarlac Branch and the local government.

This groundbreaking PALLGU initiative with the Local Government Unit of Moncada marked a first among all municipalities in Tarlac Province. Coupled with the Provincial Government of Tarlac's premium amount of P1.00 per kilogram, qualified beneficiaries of LGU Moncada may now enjoy a total premium of P3.00 per kilogram, further enhancing the economic well-being of local farmers and contributing to the province's agricultural resilience.

Through the continuous meetings and updates with the Provincial, Municipal and City Agriculturist Officers in Bulacan, a substantial event occurred on June 14, 2023, with the ceremonial signing of the Memorandum of Agreement (MOA) on PALLGU between the National Food Authority Region 3 represented by Regional Manager II Alwin M. Uy, and LGU-Pulilan headed by Honorable Mayor Maria Rosario Ochoa-Montejo. The MOA aimed to enhance farmer-beneficiaries' income by providing an increment of P3.00 per kilo of palay procured on top of the NFA's buying price of P23.00/kg. The NFA Bulacan expressed gratitude to Mayor Montejo for piloting PALLGU and supporting their initiatives.

With this development, the branch conveyed gratitude to the elected officials, personnel, staff and working teams for supporting the approval of PALLGU in their town. Other LGUs also appreciated the exerted effort of the employees of NFA Bulacan to present the PALLGU program and seek assistance from them, hence, promised to review and further discuss such to the Sangguniang Bayan for inclusion in the budget for the succeeding year.

Positive feedback and testimonials were received from various agencybeneficiaries stating that the rice being received is of good quality, exact in weight and fit for human consumption.

The One-Time Grant of Rice Allowance has been successfully implemented, demonstrating the vital role played by NFA and the government's dedication to helping its people in difficult times.



In fulfilling its commitment for an adequate supply of rice in times of natural calamities, emergencies and other relief operations, the NFA Region 3 distributed rice to various LGUs, DSWD and other calamity relief agencies as the country experienced severe devastation from typhoons, flooding and southwest monsoon.

RPC facilities includes, 10TPH Ricemill, 5 units Recirculating Mechanical Drier at 30TPB capacity per unit and a newly installed Silos with 1500MT capacity each. Additionally, it has a Drying and Milling Facilities designed to minimize losses,

The visit mainly focused on discussions about the utilization of driers and ricemill for the main cropping season of 2023, emphasizing partnership between the NFA and PGNE to enhance agricultural processes and strengthen the local industry. Lucero conducted data/information gathering about the operations and technical usage of the facilities of PGNE-RPC which will be included in an on-going assessment and creation of Terms of Reference (TOR) for the Nueva Ecija Branch Office potential utilization of PGNE-RPC services. From then on, series of courtesy visit and meetings were conducted with the Provincial Government to present the data gathered and to finalize the MOA between PGNE and NFA.

The partnership was even aired at the local TV network of Nueva Ecija named as TV 48. Governor Umali proved that he really wants to support the NFA's mandate and to show his belief that we can have a progressive and sustainable success in agriculture farming.

Their dual objectives included scouting palay for purchase and disseminating vital information about the NFA's increased buying price. This substantial hike, from Php 19 to Php 23 for clean and dry palay, aims to fortify the agency's presence in the region, ensuring steadfast support for local farmers.

On September 20, 2023, BM Benjamin De Guzman, along with Acting ABM Rhona P. Talens, SGO Jeanette Go, and Acting WS Luigi Edison Balbin, was invited to the monthly meeting of the Barangay Agriculture and Fisheries Council (BAFC). The meeting focused on discussing the status of irrigation water and the NFA's price adjustment from Php 19 to Php 23. This gathering served as a platform to strengthen bonds within the agricultural community, fostering alliance and shared insights among its members. The implementation of Buffer Stocking Incentives was highlighted, encouraging farmers to deliver more palay to NFA, ensuring a fair return on their investments. This collective effort stands as a testament to the commitment to bolster the agricultural sector and support the hardworking farmers in the area.

The Local Government Unit (LGU) of Moncada, in a reaffirmation of its commitment to supporting the National Food Authority's (NFA) Palay Procurement, recently conducted the pay-out for the first batch of beneficiaries under the Palay Marketing Assistance Program for Legislators and Local Government Units (PALLGU) on November 10, 2023.

Qualified farmers were set to receive a maximum amount of P10,000.00 per beneficiary, representing an additional premium of P2.00 per kilogram on the 100 bags of palay delivered. The pay-out event took place at the Moncada Public Auditorium, marking a significant step in providing financial assistance to local farmers.

The PALLGU pay-out program was attended by NFA Tarlac Branch Office, led by Branch Manager Engr. Charles G. Alingod, the Provincial Government of Tarlac – Office of the Provincial Agriculture, represented by Ms. Alicia Cruz, and the LGU of Moncada, led by Municipal Mayor Hon. Estelita M. Aquino, Municipal Vice-Mayor Ramon Benito M. Aquino, and Sangguniang Bayan Members.

BM Alingod stated, "Ang layunin ng programa kasama ang LGU Moncada ay matulungan ang ating mga small scale farmer dito sa bayan at masuportahan ang food security ng ating bansa." He also expressed gratitude to the LGU of Moncada, particularly Mayor Estelita M. Aquino, for their continuous support to NFA, ensuring local farmers of the agency's readiness to procure palay year-round.

It was further announced that the PALLGU partnership will become a regular program for LGU Moncada, supported by an ordinance providing an annual fund allocation.

LINKAGES WITH LGUS AND OTHER AGENCIES EXECUTIVE ORDER NO. 39: NFA TAKES PART IN RICE PRICE CAP MONITORING



President Ferdinand R. Marcos, Jr. has imposed the Mandated Price Ceiling on Rice in his Executive Order No. 39 dated August 31, 2023. There had been reports of a worrying rise in the retail pricing of necessities despite a consistent supply of rice due to a widespread practice of allegedly unlawful price manipulation. As a result, mandatory price ceilings on rice were imposed and implemented nationwide in response to the growing cost of food upon the advice of the Department of Agriculture (DA) and Department of Trade and Industry (DTI), as follows:

Rice Variety	Mandated Price Ceiling
Regular Milled Rice	P41.00 per kilogram
Well-Milled Rice	P45.00 per kilogram

The NFA, as the deputized member of the DA's Price Monitoring Team, provided assistance in monitoring rice prices in the public markets and technical support on the proper classification of rice varieties. This joint initiative reflects commitment and cooperative efforts to uphold fair pricing practices within the market, ultimately benefiting consumers and ensuring adherence to government regulations.

The price ceilings shall remain in full force and effect unless earlier lifted by the President upon the recommendation of the Price Coordinating Council or the DA and DTI.

Pay it forward! The concept is old, but the phrase may have been devised by Lily Hardy Hammond in her 1916 book In the Garden of Delight. This serial reciprocity describes a situation where someone who receives good deed repays others instead of returning the favor to the original benefactor.

This is how Ms. Rodora Mares Cordova, known to NFA employees as "Ate Dhors", described the lifestyle she leads while running the canteen her mother started at NFA Nueva Ecija. It was in 1976 when her mother, Mrs. Isabel Mares, popularly known as "Aling Sabel", started selling "lugaw and Pan de Carne" along the sidewalk of Warehouse No. 10.

After some time, she learned that there were "Kubo" or stalls available to operate as food kiosks. However, other vendors had set up their goods to all three (3) stall units without the office's knowledge, selling nearly identical goods to those that Aling Sabel is selling. She made the decision to seek Ms. Marcelina T. Sampoleo, the regional accountant, who is acquainted with her, for permission to set up a single stand for her merchandise. She was the first to approach the management with her sincere wish to use this space for her little business, thus thankfully, her action was appreciated. Ms. Sampoleo assisted her in obtaining one (1) unit of kubo. After a number of years, the three stalls' materials were changed in 1981 as repairs were finally done.

Regretfully, in 1987 the two other kiosks gradually disappeared, leaving only Aling Sabel's kiosk standing. It evolved into a canteen from merely selling bread and lugaw, with the employees buying their products. She served all the workers and their families her undivided attention and care.

FROM SCRAP TO CRAFT

WHEN TALENT MEETS PASSION

Anytime, anywhere, whenever you need them, they will be there, along with their tools – this is how they describe the Facility Management Team, particularly, Mr. Ruel I. Non and Mr. Benjje B. Capulong, the Mechanical Plant Operators of National Food Authority – Tarlac Branch Office.

They are currently assigned at the Aguso Compound wherein they are in-charge of the maintenance and operation of post-harvest facilities. At present, there are three existing mechanical dryers in the Compound, the Shin Hueng, Suncue, and Greenmac dryers which were acquired in 1989, 1998, and 1999, respectively, Due to their natural wear and tear, they were prone to breakdown and require frequent repair and maintenance. Other interlocking parts and electromechanical system of said dryers are outmoded and are no longer available in the market. The Facility Management Team were instructed by their then superior and now the Acting Branch Manager of Tarlac Branch Office, Engr. Charles G. Alingod to repair and maintain the dryers to ensure performance and function despite their existing condition. Moreover, instead of procuring an electronic computer system for the dryers that cost about P100,000.00, they attempted and successfully modified the systems into manual ones which resulted to same performance with that of an electronic computer system. Hence, the branch was able to continuously serve the drying needs of the farmers during its palay procurement operations.

Aside from maintaining the post-harvest facilities, Mr. Ruel and Mr. Benjie, in addition, provided assistance in minor repairs of service vehicles. In their spare time, they also do carpentry and electrical works such as repairing office and warehouse doors, installation and modification of spotlights, and replacement of worn-out parts of the filing cabinets, laboratory equipment storage, office tables and the like.

Through the years, the branch benefited and has saved immensely since they no longer hired welders, electricians, maintenance workers, and carpenters whenever Mr. Ruel and Mr. Benjie are able and available to do such works.
